


Reduce barriers "friction" to enrollment Equity:

Nelnet Payment Plans



Traditional term based plans

- Tuition, Housing and books
- 2-12 monthly or bi-monthly payments

International payment plans

- Offered specifically for International Students
- Payments through Convera

Past Due Payment Plans

- Precollections
- Balance repayment

Long Term Payment Plans

- Beyond 12 months of payments
- TILA and HEOA compliant

Benefits of traditional payment plans



Provides flexibility and affordability for students and families

Increased student retention

How does Kishwaukee College use Payment Plans

 Strong Strategic Directive to Reduce Barriers for Students

- College Pays Enrollment Fee
- No Downpayment required, if registering prior to semester start
- Payment Not Due until One Month after Classes Start

Integration with your ERP



- SSO: Pass-Through Authentication
- RTPN: Real-Time Payment Notification
- RTAA: Real-Time Account Activity
- RTAN: Real-Time Agreement Notification
- File Processing: EOD and Balance Compare



Kishwaukee College Colleague SaaS ERP Migration

TIMELINE

October 2022 – Kishwaukee College Makes Colleague SaaS Commitment

- Nelnet wasn't Compatible with Colleague SaaS
- Investigated Alternative Payment Plans

July 2024 - Nelnet was Ready for Colleague SaaS Integration

- Kick Off Meeting Held
- Kishwaukee College was Alpha Client

Project steps

- Weekly Meetings with Nelnet and Colleague
- Outstanding Support both Nelnet and Colleague

Colleague SaaS with Nelnet – Went Live November 2024, Ready for Spring Semester



What's Next

Past Due Payment Plans





Last ditch effort prior to sending student to Collections



Address outstanding debt while also providing for transcript requests



Down payments provide for student commitment and reduction of receivables



Allow students to re-enroll with commitment to pay past due balance



Automation and Integration are available

Payment Plans - Additional Functionality



Nelnet Past Due Payment Plans

- First Action, Prior to Collections
- Plan Length Variability
 - Length based on Balance 3 Months, 6 Months, 12 Months
- Kick Off Meeting April 2025

Short term; Cohort Specific Payment Plans

- Nelnet Past Due Plan offers Flexibility
 - College Creates Terms based on Cohort
 - Length and Minimum Balanced Specialized per Cohort
