- Competency 3.3: Students will outline steps involved in the processing of a crime scene, including photographing, searching, collecting physical evidence, recording, and reconstructing the crime.

- Competency 3.4: Students will discuss the importance of physical evidence that may be at a crime scene and the methods used by crime scene personnel to process that evidence.
- Competency 3.5: Students will highlight the details of an important crime scene investigation.

Outcome #4: Students will become familiar with the techniques of interrogation and interviewing which are constitutionally acceptable.

- Competency 4.1: Students will gain an appreciation of the importance of interviews in the investigative process and methods used by successful interviewers to obtain information.
- Competency 4.2: Students will explain innovations in interviewing techniques and special techniques in interviewing special populations: children or victims of sexual assault.
- Competency 4.3: Students will demonstrate interview methods used by successful investigators.
- Competency 4.4: Students will demonstrate techniques used by interviewers and interrogators in recording interviews and interrogations for later use and for presentation in court.
