CATALOG DESCRIPTION:

This course provides the student with an introduction to the manufacturing world and provides specific instruction to facilitate safe work practices in industrial environments. Covers fire safety, pressurized gases, electrical hazards, first aid, safe machine usage, personal protective equipment and basic communication skills including written and oral. Students will also become acquainted with OSHA policies, understanding of workplace recordkeeping. The OSHA 10 Hour General Industry card will be earned upon successful completion of this class. Students will have the opportunity to earn the Safety Certification through Manufacturing Skill Standards Council (MSSC).
