Timetable of election deadlines

The dates in this calendar are calculated in accordance with the provisions of Public Act 103-0586 (effective May 3, 2024) and Public Act 103-0600 (effective July 1, 2024) which shifted the candidate filing periods and related dates for most offices up by 28 days.

Date	Action Needed
August 20, 2024	<p>Petition Circulation Begins for the Consolidated Election:</p> <p>First day to circulate petitions for candidates seeking election in the 2025 Consolidated Election.</p>
November 12, 2024	<p>First Day to File Candidate Petitions for the Consolidated Election:</p> <p>First day to file nomination petitions with the local election official for the 2025 Consolidated Election.</p>
November 18, 2024	<p>Last Day to File Candidate Petitions for the Consolidated Election</p> <p>Last day to file nomination petitions with the local election official for the 2025 Consolidated Election</p> <p>The Statement of Economic Interest must be filed on or before this date with the County Clerk’s office and the receipt must be filed on or before this date with the local election official who received the nomination papers.</p>
November 20, 2024	<p>When two or more petitions are simultaneously filed for the same office as of the opening hour of the filing period, the local election official shall break ties and determine the order of filing by means of a lottery. The lottery shall be conducted within 9 days after the last day of the petition filing period and is open to the public. Per P.A. 97-1044 (Effective January 1, 2013) and P.A.</p>

	<p>98-115 (Effective July 29, 2013), 2 or more petitions filed within the last hour of the filing deadline (between 4:00 p.m. and 5:00 p.m. on the last filing day) shall be deemed filed simultaneously and are included in the lottery drawing to determine the final ballot position.</p> <p><i>If necessary, a lottery drawing will be held on Wednesday, November 20 at 4:00 p.m. in the Board Room (C-307), 815 Orlando Smith Road, Oglesby, Illinois for positions on the ballot of IVCC Board of Trustees.</i></p> <p><i>Those attending the lottery should enter through the CTC building and proceed directly to the Board Room.</i></p>
November 25, 2024	<p>Last Day to File Objections to Nomination Papers for the Consolidated Election</p> <p>Last day to file objections to nomination papers of independent, new party, and nonpartisan candidates (when nonpartisan candidates are not subject to a primary) in the office of the local election official or election authority.</p> <p>Objections will be received between the hours of 8:00am and 4:30pm on November 19-22 and November 25, 2024 in C-301 at 815 Orlando Smith Road, Oglesby, Illinois</p>
January 23, 2025	<p>Ballot Certification Deadline for the Consolidated Election</p> <p>Last day for the local election official to certify candidates and public questions to the election authority to be included on the 2025 Consolidated Election ballot.</p>
April 1, 2025	CONSOLIDATED ELECTION
