<ul> <li>STEP 7: Person/Organization Compliance and Consent:</li> <li>By signing below, the person/organization requesting the information acknowledges the responsibilities and limitations regarding the use and disclosure of FTI and/or FAFSA data, which include:</li> <li>The requesting person/organization understands the legal implications of misusing FTI data, including potential fines and imprisonment as outlined under IRC \$7213, \$7213A and IRC \$7431.</li> <li>IRC \$7213 - Unauthorized Disclosure of Information - this section makes the unauthorized disclosure of FTI a felony punishable by a fine up to \$5,000 or imprisonment of up to 5 years, or both, along with the costs of prosecution. This includes any willful unauthorized disclosure of returns or return information by a federal or state employee.</li> <li>IRC \$7213A - Unauthorized Inspection of Returns or Return Information - this section refers to the unlawful act of unauthorized inspection of returns or return information. It imposes a penalty of up to \$1,000 for each act of unauthorized inspection, with the maximum penalty of \$10,000 in any calendar year, and/or imprisonment of up to 1 year, plus costs of prosecution.</li> <li>IRC \$7431 - Civil Damages for Unauthorized Disclosure of Returns and Return Information - this section provides for civil damages in cases of unauthorized disclosure of returns and return information.</li> </ul>
