Required Documentation – Court document from your state of legal residence where you were placed under legal guardianship of another person. You must currently be in legal guardianship or were in guardianship immediately before you reached the age of being an adult in your state (18 in Illinois). Please note: Court documents must state "guardianship" not "custody".
- At any time on or after July 1, 2023, did your high school or school district homeless liaison determine that you were an unaccompanied youth who was homeless, or were self-supporting and at risk of being homeless?**  
Required Documentation – Document on letterhead stationery from either your high school or school district homeless liaison verifying this status.
