**B. Income to Be Verified**

**TAX FILERS:**

- I used the IRS Direct Data Exchange on the FAFSA.
- I am attaching an IRS tax return transcript for 2022.
- I am attaching a signed copy of my 2022 1040 and Schedules 1, 2, 3, C, and F (as applicable).

**NOTE: If you were recently married and filed separate returns, you will need to submit a copy of both you and your spouse contributor's 2022 tax return transcripts.**

## **A 2022 IRS Tax Return Transcript may be obtained through:**

### Get Transcript Online

- Go to [www.irs.gov](http://www.irs.gov)
- Click "Get Your Tax Record."
- Click "Get Transcript Online." Make sure to request the "Return Transcript" and NOT the "Account Transcript."
- To use the Get Transcript Online tool, the user must have (1) access to a valid email address, (2) a text-enabled mobile phone (pay-as-you-go plans cannot be used) in the user's name, and (3) specific financial account numbers (such as a credit card number or an account number for a home mortgage or auto loan). The transcript displays online upon successful completion of the IRS's two-step authentication.

### Get Transcript by Mail

- Go to [www.irs.gov](http://www.irs.gov)
- Click "Get Your Tax Record."
- Click "Get Transcript by Mail." Make sure to request the "Return Transcript" and NOT the "Account Transcript."
- The transcript is generally received within 10 business days from the IRS's receipt of the online request.

### Automated Telephone Request

- Call 1-800-908-9946. Transcript is generally received within 10 business days from the IRS's receipt of the telephone request.

### Paper Request Form

- IRS Form 4506T-EZ or IRS Form 4506-T. The transcript is generally received within 10 business days from the IRS's receipt of the paper request form.

## **Individuals who filed an amended IRS income tax return for tax year 2022 must provide:**

- A signed copy of the 2022 IRS Form 1040X "Amended U.S. Individual Income Tax Return," that was filed with the IRS or a 2022 tax account transcript from the IRS that includes the change(s) made by the IRS, in addition to one of the following:
  - o A 2022 IRS Federal Tax Return Transcript (that will only include information from the original tax return and does not have to be signed); OR
  - o A signed copy of the original 2022 IRS Federal 1040 and the applicable schedules that were filed with the IRS.

## **NON TAX FILERS:**

- I was employed in 2022 and have attached copies of all my (and my spouse contributor's if applicable) 2022 W-2 forms and verification of non-filing letter(s) from the IRS.
- I was not employed (and or my spouse contributor was not employed), had no income earned from work in 2022 and have attached verification of non-filing letter(s) from the IRS.
- I (and/or my spouse contributor) certify that I do not have a Social Security Number, an Individual Taxpayer Identification number (ITIN), or an Employer Identification Number (EIN) and I am unable to obtain a Non-filing Tax Document from the IRS for the 2022 tax year. A signed statement must be provided

To obtain a Verification of Non-Filing letter, either call 1-800-908-9946 or  
 go to <http://www.irs.gov/pub//irs-pdf/f4506t.pdf>  
 and fill out a Form 4506-T Request for Transcript of Tax Return  
 (make sure to check 7 - Verification of Nonfiling) and mail to the address provided on the form.

## Illinois Residency Verification

The Illinois Student Assistance Commission (ISAC) requires independent students to verify Illinois residency.

*For an independent student to be considered a resident of Illinois they must have physically resided in Illinois for 12 continuous full months immediately **prior to the start of the academic year** for which assistance is requested and Illinois must be their true, fixed, and permanent home.*

### Acceptable Documents:

- A Valid 2023 state of Illinois income tax return with an Illinois address
- Illinois auto registration
- Residential lease signed by you and your landlord with dates covering 8/15/23 through 8/15/24
- Illinois driver's license **or** Illinois State Issued ID issued prior to August 15, 2023
- Utility or rent bills with dates covering 8/15/23 through 8/15/24 - You must submit **at least six**
- Statement of benefits history from the Illinois Department of Public Aid showing residency between 8/15/23 and 8/15/24
- Statement of benefits from the Illinois Department of Employment Security showing residency between 8/15/23 and 8/15/24
- Statement of Benefits from the Social Security Administration showing Illinois residency between 8/15/23 and 8/15/24

- I have not lived in Illinois for one year
- I did live in Illinois during this period; however I am unable to provide supporting documentation. I understand that checking this box will render me ineligible to receive the Illinois MAP Grant.
